#### Sad News.

Over the past few weeks I have been told of the passing of two old stalwarts of archery in Kent. The first of these was Del Bumstead who many will have known through both shooting and organisational work for various clubs.

The second was Bob Jones from Leaves Green Bowmen. Apart from being a personal friend of mine Bob did a lot of work for the County and his Club. Carole Johnson writes:-

"Bob Jones passed away in his sleep on the 1st of March aged 89.

He had been suffering from Alzheimer's for several years.

He began shooting in 1974 with Leaves Green Bowmen and continued to shoot until five years ago.

Over the years he shot recurve, compound and long bow disciplines.

In the 1980's he was a member of the KAA County Team.

He was always an officer in L.G.B working for the club, its members and the club future."

Many of us will recall Bob's sense of humour and the joy of shooting with him at various events.

Bob was also one of the 'subjects' of cartoons published in 'Toxopholitus' a series of cartoons about archery and in particular Leaves Green Bowmen. "Union, Trueheart and Courtesie" sums Bob up.

## Archery for those with a disability.

Theses are important documents and I would suggest that all clubs ensure their committee read them and take note. This applies especially to those clubs running tournaments where you have specific duties as a 'service provider'.

I have heard tales of a shoot charging double because a wheel chair archer took up two spaces on a shooting line...this would have led to a court case!!

Note.. The shoot on May 21st will not determine the KAA Champions. This will be done at the KAA championships in August.

Reminder to County team archers (and hopefuls!!) Make sure your scores are sent in to the Record Officer!! I am told that he will not take scores from tournaments results himself as he does not have time to search them all for KAA members!! Please send in your scores yourself if you think the club R/O has not done so. Better safe than sorry.

If submitting scores for Kent Bowmen please refer to the guidelines later in this newsletter.

In addition clubs scores submitted over the years have been kept by the Records Officer. These will be destroyed after April 30th if they are not wanted by clubs. If your club does want them back please contact the Records Officer as soon as possible.

A reminder that all clubs should send a copy of their constitution to the KAA Secretary if there any changes. Given that most clubs will have had to make changes due to the requirement of having a Club CPO and adopting the AGB policy the changed constitutions should have been sent in.

#### APPENDIX - CURRENT DISTANCE AND SCORE REQUIREMENTS

#### Table 1: Distances Required (with effect from 01 March 2010)

For a round to qualify for use in obtaining KCB, it must contain a distance at least as far as the required distance shown in the following table:

The above distances apply to all bow styles.

#### Table 2: Score Level Required (with effect from 01 March 2012)

After converting the score for a qualifying round to an equivalent handicap level (using the 2010 edition of the ArcheryGB handicap tables), the following table shows the handicap level required for KCB:

The KCB score requirements are currently set midway between those for 1° Class and Bowman/Junior Bowman.
