#### **RECORDS** and score submissions

All club members should by now have been sent a copy of the updated KAA Policies including those relating to record score claims and score submissions in general.

Full details are on line but a summary is

Records - must include results sheets or score sheets with three signatures (including "shot to AGB rules"). Indoor scores to be - Recurve and Compound classes A to C; Longbow and Barebow classes A to F (longbow and barebow to use recurve class tables).

Outdoor scores must be rounds of - 1) minimum 8 dozen arrows; and 2) including archers maximum distance; and 3) minimum 1st class score. All three parts must be true.

Field scores are now accepted.

All scores are to be submitted on the Excel spreadsheet forms.

# **Sittingbourne Community College Archers**

Are hosting a new event on Saturday 28th July.. The Para Record Status 720 and Festival. Details on the KAA website and will be sent out to all KAA clubs. This event is open to all para and VI archers. You do not have to do the Record Status 720.. There are other rounds available as well.


# **Range Registration**

AGB are now in the process of contacting the very few clubs who have not complied in order so that all AGB clubs are on the list. My mole at AGB also tells me that where there is doubt about a club's self certification (or a complaint has been made about safety) they may be asked to receive a visit to check for compliance.

If your club is hosting a competition and has asked a Judge to officiate the certificate mist be available for that Judge on the day.
