
I was sent a photo of our recently successful County Judge to put in the news letter so here it is, taken at the Kent Championships last month.

AGB and DBS checks... a reminder.

All coaches and those archers who work with children or vulnerable adults should have a DBS check carried out. This is a <u>free</u> process that is carried out through AGB and as most of it is done on line does not take much time or effort. A reminder that your certificate is running out may not be sent but you can check your status via the AGB portal.
