Directions:

The venue is conveniently within 5 minutes of the A249 junction with the M2 motorway. The venue will be signposted from Pett Lane. A map can be provided via email to confirmed entrants.

Rounds:

The rounds to be shot will be:

Kent Archery Association World Archery 24 Unmarked Target Round.

The course will be a loop of 12 targets which competitors will complete twice.

The loop will consist of unmarked distances.

This event is organised by the Kent Archery Field Committee on behalf of the Kent Archery Association.

ENTRY INFORMATION

Eligibility: This tournament is open only to archers who are existing members of ArcheryGB or another World Archery member association.

Proof of membership will be requested at the tournament.

Club: Because this event is organised by a county association, you must enter the tournament either as a member of your first-claim club (GNAS Law 20.b.v) or as a Direct Member of KAA/other county/ArcheryGB (provided, of course, that you are).

Awards: The title of Kent County Champion will be awarded to the top placed competitor in each category. Medals will be awarded dependant on the number of competitors in each category.

1st place medals will be awarded for categories with two or more competitors.

2nd place medals will be awarded for categories with three or more competitors.

3rd place medals will be awarded for categories with four or more competitors.

To qualify for awards, all classes must shoot as follows:

Barebow, Traditional, American Flatbow and Longbow – Blue pegs

Recurve – Red pegs

Compounds – Red Pegs

Compound Barebow – Blue Pegs

All ages will be those effective on the 13th October 2018.

The closing date will be strictly adhered to – late entries will be allowed if space permits. Late entries will incur an additional £1.50 fee. Once full a waiting list will apply to entries received before the closing date.

Please complete the entry form in **BLOCK CAPITALS** and return it with payment. Entries can only be accepted if they include adequate contact details, the archer's signature (plus parent/guardian signature for juniors) and full payment. Postal entries only. Results will be available on the KAA website.

Registration: from 09:00 a.m.

Practice: Open from 08:30 and will close 15mins prior to assembly.

Assembly: 10:00 a.m. Shooting is expected to commence at approximately 10:30 hours.

Judges: Mr. D. Lovell MBE. Mr Tony Harris

Dress Code: It is recommended that competitors wear bright visible colours and suitable footwear for muddy and uneven terrain.

Lost Arrows: In accordance with World Archery rules, searches for lost arrows must not delay shooting groups. Searches for lost arrows may continue on completion of shooting where the work party may assist. Please report all lost arrows to the tournament organiser at the end day, upon completion of scoring.

Disclaimer: Neither the Kent Archery Association nor the owners of the grounds can accept responsibility for loss or damage to equipment while on, entering or leaving the venue. No responsibility will be accepted for damage to arrows missing or passing through a target boss.

Refreshments: Tea and Coffee will be available at designated rest points on the course. No other refreshments will be provided. It is suggested that competitors bring adequate refreshments in a small rucksack to carry with them around the course.

Toilets: Chemical toilets will be available at designated rest points on the course.

Parking: Parking space will be clearly indicated; please park considerately and do not leave your car on any roadway.

Photography: To comply with the ArcheryGB Policy for "Safeguarding Children, Young People & Vulnerable Adults", any person wishing to pursue any form of photography for any purpose is required to report to the tournament organiser before starting and to comply with any conditions given.

Juniors: All competitors under the age of 18 must be supervised by a parent, guardian or other nominated responsible adult at all times.
